**Title:** Statistician, Department of Justice, Bureau of Justice Statistics **Bio:** After 6 years of working as a research and policy analyst for the Illinois Criminal Justice Information Authority, Lindsay earned a PhD in Public Policy at Carnegie Mellon University. She completed a postdoctoral fellowship at the Pennsylvania Commission on Sentencing, and subsequently worked for the non-profit Justice Research and Statistics Association.
